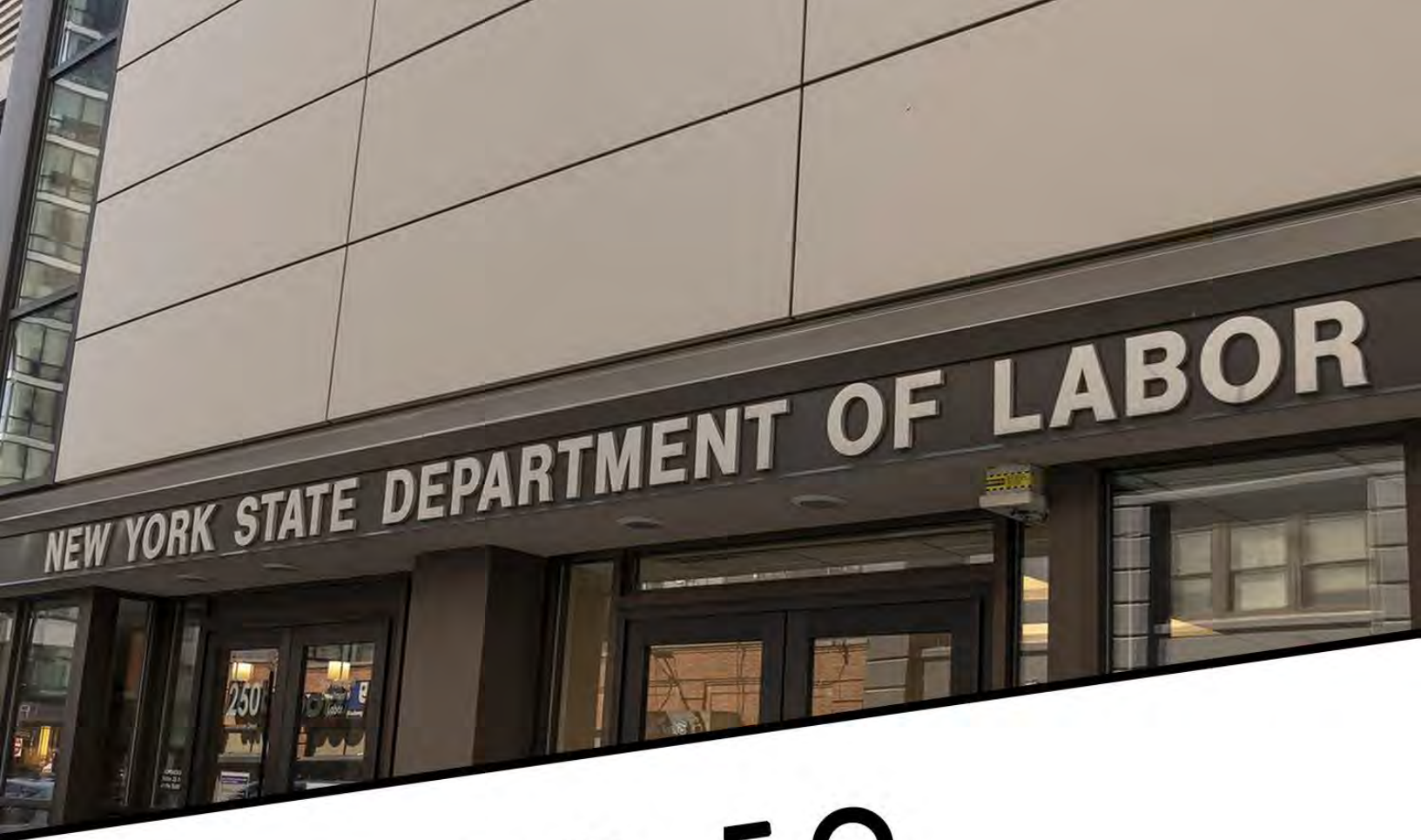

 - Do not belong to a NYSIF Safety Group other than Group 90
 - Have a comprehensive Safety Program, Drug & Alcohol Prevention Program, and / or Return to Work Program developed and implemented*
- * We work with employers to develop the necessary Programs to qualify in addition to helping them apply for the credits
- **100% success rate**; every company we have helped apply has been granted credits
